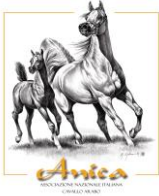

The European Championships 2017 will be organized in the FIERACAVALLI area, inside pavilion n. 9, which is provided with heating system. The EC is an ECAHO affiliated SHOW (affiliation nr. **118/2017/ITA**) and it is under EAHSC rules (annexed). The **Blue Book 2017** is fully applicable.

Due to the importance of the event and the already large number of persons in the ring and prering, the organizing committee will not allow the presence of probationer of any kind. The organizing committee reserves the right to modify the present programme for the good success of the show. The dope testing of all 6 champions is compulsory, further horses may be tested at the discretion of the DC or Jury. No class may be split unless there are 11 or more horses entered, combination of a class with the next age group of the same sex is permitted if the number of entries for the class is below 3 (three)

CONDITION OF ENTRY

Open to horses that are registered at birth in a studbook of a European Member Country of ECAHO (as defined in Art. 3.2 of the Constitution of ECAHO), and in any WAHO recognized studbook by the closing date of entries

No horse will be permitted to enter the show ring unless its name and all other relevant details have been printed in the catalogue.

An equine passport including a validated graphic description of the horse is mandatory for all international shows in European Union member countries (EEC directives).

b) Horses should have qualified at an ECAHO affiliated show in one of the following ways:

Qualification:

All horses except yearlings should have qualified at an ECAHO affiliated show in one of the following ways:

- **1st to 5th** place at an A or B or National Championship Show
- **1st to 3rd** place at a C National or C International or C European Show.
- **1st to 2nd** place at Specific Origin Shows

Horses registered in countries which are not Members of ECAHO must either qualify in an ECAHO affiliated show or may qualify at other shows accepted by the EAHSC, such as:

- a title of Champion or Reserve Champion or "TOP TEN" at the US Nationals
- a title of Champion or Reserve Champion or a 1st place at the US Scottsdale Competition
- a title of Champion or Reserve Champion in US "Regional" competitions
- a title of Champion or Reserve Champion or 1st to 3rd place in an official National Championship show
- 1st to 3rd place at the US Las Vegas show

Yearlings do not need to qualify for these shows..

Only open halter classes will be considered

Qualification and registration of horses to be checked by EAHSC. The horses will be disqualified if they do not have the required qualifications and registration and the entries will not be refunded.

METHOD OF JUDGING THE CLASSES

Five judges (will rotate) will judge each class independently from one another and without catalogue according to the following criteria: type, head and neck, body and top line, legs, movement, based on the 20-points-system with half points.

RULE FOR TIES

The higher place will be given to the horse with the most points for type. If there is still a tie, the higher place will be given to the horse with the most points in movement. Failing a decision on either of these, one judge chosen by ballot will name his preference (This applies to the places 1-5 of each class).

METHODS AND RULES OF JUDGING EUROPEAN CHAMPIONSHIPS

Open method

First and second placed horses of each class qualify to take part in the championships. Additionally, some other horses qualify to take part in the so called "TOP FIVE". The exact number of horses which are entitled to take part in the "TOP FIVE" depends on the total amount of participants of each class, according to the following table:

5-6 starters	= places 1-2 qualify
7-8 starters	= places 1-3 qualify
9-10 starters	= places 1-4 qualify
11 and more starters	= places 1-5 qualify

The title as "TOP FIVE EUROPEAN CHAMPIONSHIP" is an official title, which can be used as such. A place within the first five horses of a class does not authorize to use this title.

CHAMPIONSHIPS and TOP FIVE will be judged comparatively with new ECAHO method, blue book 2017, as explained here:

All Gold Medal Champions will be drug tested. In case the result is positive, costs have to be carried by the owner of the horse.

RULES FOR TIES AND CHAMPIONSHIPS

Open method with top 5

The Gold, Silver and Bronze medal winners will be selected from amongst all the horses which have qualified in their respective classes for each championship

1. The Championships will be judged as follows:
 - a. All the horses qualified for the championship will enter the ring and line up according to the numerical order of their catalogue numbers.
 - b. The horses will be judged individually, standing and trotting.
 - c. Each judge will nominate his choice for gold silver and bronze medals together at the same time, from amongst all the horses qualified for the championship.

Points will be given to the nominated horses as follows:

- A horse nominated by a judge for Gold Medal will receive 6 points.
- A horse nominated by a judge for Silver Medal will receive 4 points.
- A horse nominated by a judge for Bronze Medal will receive 3 points.
- the horse nominated by a judge as 4th TOP FIVE Medal will receive 2 points.
- the horse nominated by a judge as 5th TOP FIVE Medal will receive 1 points.

The **Gold Medal** will be awarded to the horse with the highest number of championship points.

The **Silver Medal** will be awarded to the horse with the 2nd highest number of championship points.

The **Bronze Medal** will be awarded to the horse with the 3rd highest number of championship points.

TOP FIVE medals will be awarded to the following 2 horses with the 2 other highest number of championship points .

In the case of a tie, the Rules for Ties in championships will be followed.

The judges will not discuss the horses.

2. A fourth horse will be selected, which will become the Bronze medal winner should one of the three medal winners be disqualified. If this exhibit is not apparent from the voting papers, the judges will be asked to nominate one.

This horse will not be announced. In the event that two or more of the medal winners are disqualified, no further substitution will be made.

3. All horses that qualify for their respective Championships must take part in the Championship. Unless a certificate from the DC veterinarian is produced, failure to compete will disqualify the horse from the show, with its record of score and class placing being deleted and the horse being disqualified from showing for the period of one year as from the date of the show. In the event of a disqualification, horses placed behind the disqualified horse will move up a place in the class. Should a horse be sent out of the ring by the judges or taken out by the handler for any reason, it will be deemed to have taken part in the championship.

DISCIPLINARY MEASURES

At the discretion of the DC members, ringmasters, stewards or show officials with regards to unruly behaviour and /or abuse of horses the following disciplinary measures may be taken:

- 1) Verbal Warnings
 - 2) Yellow Cards
 - 3) Red Cards
- as foreseen in ECAHO Blue book 2017.

Rosettes for all participant,
ANICA's trophies for 1-5 placed horses,
ECAHO's bronze trophies for Gold Medal and ANICA's trophies for Gold, Silver and Bronze medal,
Top five champions: plate and special rosette.

ALL KIND OF ENTRIES- RESERVATIONS

The closing date of all entries (box, vip table, advertising pages, sponsor request) is **04 of OCTOBER 2017**, Entry fees for late entries or late payments will be raised by 20%. Entries will be accepted only if accompanied with the receipt for the total payment done by bank transfer only (no cheque, no euro-cheque). Entries will be accepted according to the available boxes , uncompleted entries will loose the arrival-priority . The Entry Form must be accompanied by a photocopy of the registration document (passport) with diagram of horse. No reimbursement for cancellations communicated after the closing date (04/10/2017)no change of horses will be accepted after the closing date. Rates are VAT included, if you have and EU VAT, you are VAT free but you have to indicate your VAT code on the entry form.

ARRIVALS AND DEPARTURES

Animal handling operations (arrival at the Exhibition Centre) The vehicles used to transport animals may access the Exhibition Centre after check-in at the Re Teodorico parking area in Viale dell'Industria exclusively through gates:

- GATE E

24/10/17 - time 7.30 - 20.00

25/10/17 - time 7.30 - 24.00

- GATE C

25/10/17 - time 7.30 - 20.00

- FAIR CODE 091VR77M

The drivers of such vehicles must present on entrance to the Exhibition a certificate of cleaning and disinfection of the vehicle itself issued by the Veterinary Service of the Health Authority of origin competent for the territory, on pain of exclusion of the animals from the Exhibition (yellow card with the wording "DISINFECTED", stamped, dated, signed and indicating the number plate and time of disinfection - article 64 Reg. Pol. Vet. n. 320; O.M.

29 May 1992). Breeders or their persons (drivers/carriers of the vehicle used to transport animals) will be given the "O Hourly Pass" (Gates C & E) indicating the entrance time for vehicle entrance/exit. The vehicles, after completing the specific controls and collecting the foregoing pass, may proceed to unload the horses (on days 24 and 25/10/17).

On consignment of this "Pass", a sum of € 100 VAT included must be paid by way of deposit. The vehicle may remain inside the Exhibition Centre for handling operations for no more than one hour. Should the vehicle leave the Exhibition Centre after two hours of entrance, the deposit will not be refunded. The assignment of boxes is performed by specific personnel, located in the Re Teodorico parking area in Viale dell'Industria and/or the veterinary service in "Hall 10" tel. 045 829 7020 from day 24/10/17. On completion of animal unloading operations, manure must be eliminated from the vehicle before washing and disinfection operations, exclusively in the specific compound area located in Area F. In order to be authorised for exit from the Exhibition Centre, vehicles absolutely must be washed and disinfected at the specific station located near Gate G. After completing the foregoing operations, vehicles absolutely must exit through Gate G where, if requested, passes will be consigned for parking in the specific car parks for vehicles such as motor-homes, caravans, van and trucks. These vehicles may not in any way whatsoever remain parked inside the exhibition centre, on pain of compulsory removal at the cost of the infringing party.

All exhibitors must collect their catalogue and back number by ANICA's office. Disciplinary measures will be taken against exhibitors who change their allocated boxes without the organizers permission.

HEALTH DOCUMENTS

Health vigilance and prevention of contagious diseases during the Event are performed by the Veterinary Service of ULSS (Health Authority) n. 20 of the Veneto Region. Vehicles, vans and railway wagons used and authorised for transport of horses must be accompanied by a cleaning and disinfection certificate. Horses entering from Italian territory through Verona Exhibition Centre must be accompanied by an identification document (**Passport**) certifying **enrolment in the national horse stud book** in conformity with the dispositions of Decree 29/12/2009 and relative implementation procedures (Operative Manual as per the D.M. 26/09/2011) and per the D.Lgs 16 February 2011, n 29, "Penalties for infringing Regulation (EC) n° 504/2008 implementing the European Directive 90/426/CEE n° 90/427/CEE on the identification of equidae as well as the management of the stud book by MIPAAF". Equidae that are more than six months old, coming from territories with specific risk situations, especially referring to particular areas or kind of breeding, have to be subjected to testing for equine infectious anaemia and results must be written in the accompanying documents, as suggested by the note 0019634-P - 29/10/2012 of the Public Veterinary dept. of the Ministry of Health (Decree 6th August 2010 - National Monitoring Plan for the equine infectious anaemia - specifications that follow the expiry of the previous plan).

In conformity with the dispositions of Article 31 - DPR 320/54, the carrier must fully fill out Form IV as per the decree of the Ministry of Health dated 16 May 2007. A copy of this declaration must be consigned to Veterinary Service personnel.

Horses from member states of the European Union must be accompanied by:

- an identification document complying and in accordance with the Regulations (EC) n. 504/2008 by the Commission of 6th June 2008 implementing the Council Directives 90/426/EEC and 90/427/EEC as regards methods for the identification of equidae;
- conform to Directive 90/426/CEE, as ratified in Italy with DPR 243/94.

Horses **from other countries** must transit through a Frontier Inspection Point (**PIF**) and be accompanied by a "Common Entrance Veterinary Document" (**DVCE for animals**) issued by PIF.

Exhibitors must immediately inform the official veterinary surgeons on service of any case, even suspected, of contagious diseases as per Article 1 of the Regulations of the Veterinary Police 8 February 1954 n. 320 as amended. N.B. The Organisers hereby reserve every right to implement full observance of the health standards that hereafter and through to the Fieracavalli 2017 event itself.
